As CEC celebrates its 100<sup>th</sup> anniversary and attention turns to the future, the Pioneers Board of Directors felt it was an opportune time to engage in strategic planning. The Board has authorized a contract with a strategic planning consultant to assist the organization in re-evaluating its name, mission, vision, core activities, and membership benefits. This work will be conducted December 15, 2021 – May 15, 2022.

Members will receive a short initial SurveyMonkey survey link the week of January 3, 2022. We encourage the participation of every Pioneers member to provide input on several topics related to the mission and activities of the Pioneers. Among the questions to be posed is consideration of a name change for the division. Our intent is to analyze the initial responses in order to provide some preliminary results at the Convention.

Members attending the CEC Convention in Orlando (Jan 16-19, 2022) who attend the annual division meeting will be provided with an update on the strategic planning process and afforded an opportunity to provide input.

The entire membership will be invited to engage in additional surveys and focus groups during the Spring that will help shape the future of the Pioneers. More information will be forthcoming. Treasurer's Report

Pioneers is ending the 2021 year is a financially stable position. The Covid shut-down has allowed us to save money and we are ending the year with a positive balance with income exceeding our expenses. In addition, the activities of the Professional Development Committee provided unanticipated additional revenue of over \$600.

At the December Board Meeting, the 2022 budget was approved. This budget is based on 215 active members and includes the anticipation of professional development activities to support the revenue side of the budget. Pioneers has two reserved funds that are not included in the annual budget, the June Jordon Fund and a line item for potential grants that may be received. The June Jordon Fund relies solely on donations and must be used for activities specific to the fund. The grant line allows Pioneers to apply for appropriate grants from CEC or other sources and will track those funds separately.

The CEC 100th Anniversary activities bring some one-time costs associated with these special events and the board elected to cover these costs with money from savings.




